SCORE INTERNATIONAL SPONSORS PAY CONTINGENCY AWARDS TO THOSE CONTESTANTS WHO MEET ALL OF THE ABOVE CRITERIA AND WHO COMPLETE THE RACE. "No Finish" (DNF) situations do not mandate that the sponsor pay contingency awards. Any contestant who falsifies his declaration will be subject to disqualification without appeal. This would result in a forfeiture of cash purse, all contingency monies, and entry fee. A participant may change products after making a declaration, but he must make the change known in writing prior to the beginning of the competition. Such written declarations must be submitted to the Contingency Director and obtain a receipt confirming official acceptance of the change.
